WHAT WE DO

ACRS fulfils its purpose through a combination of advocacy, events, and knowledge sharing for our members.

LOCAL GOVERNMENT NETWORK

The Local Government Network (LGN) is a place for ACRS members who work within or want to focus on road safety at the local government level.

The LGN provides exceptional opportunities to connect with progressive road safety professionals, practitioners, and stakeholders.

Many of our members are local government practitioners, however the LGN also attracts members from peak insurance bodies; universities; federal and state government road safety and transport agencies; road owners; emergency service providers; research organisations; road safety equipment providers; transport planning; engineering; technology; and logistics organisations.

ACR

It's a place to share information, collaborate on ideas, seek help for issues you are experiencing, and celebrate the successes you've had.

The LGN provides you with opportunities to:

- Hear about what councils from across Australasia are doing in relation to road safety.
- Discuss what works and what doesn't in relation to local road safety initiatives.
- Connect with like-minded professionals, practitioners, and stakeholders.
- Share ideas and resources in online meetings and webinars.
- Attend pre-conference workshops and networking events.

ADVOCACY

We advocate for the prevention of crashes, and a systematic approach to road safety. We do this through: the development of Policy Principles which underpin the evidence-based methodology by which we work; Policy Position Statements that provide a concise overview of a road safety policy issue and ACRS's position; and Road Safety Submissions which all members are actively encouraged to participate in.

PUBLICATIONS & RESOURCES

The Journal of Road Safety (JRS) is the peer-reviewed scientific journal published quarterly by the ACRS. This is an excellent resource for those working in the road safety space who are seeking up-to-date research.

The ACRS also provides access to the most up-to-date road trauma statistics for Australia, New Zealand, and international regions; road safety strategies for Australia and globally; Australian road safety reports; and abstracts from past conferences.

ACTIVITIES

ACRS holds a number of events both in person and virtual throughout the year in different jurisdictions, providing opportunities for members to network and share ideas.

Australasian Road Safety Conference (ARSC)

The ARSC is the region's biggest road safety conference hosted by ACRS and Austroads that brings together stakeholders and decision-makers from Australasia and international jurisdictions, providing an opportunity to engage, challenge, and exchange ideas.

Chapter Events - Australia & New Zealand

ACRS is represented in different jurisdictions by state-based Chapters. The Chapters have Committees that organise local events in the form of seminars, forums, or workshops.

Early Career Network (ECN)

The ECN is for anyone who considers themselves in their early career (from students to those with several years of experience) in either the road safety industry or academia.

Women in Road Safety Network (WiRSN)

The WiRSN is for those dedicated to empowering, advocating, and supporting women in road safety in their efforts to eliminate road trauma globally.

International Outreach Chapter (IOC)

The IOC connects ACRS members working across the globe, creating an opportunity to share knowledge, experience, and expertise.
